L&T and EADS Ink Pact for Opportunities in Aerospace & Defence

Bangalore, February 09, 2007: Larsen and Toubro Limited (L&T) and European aerospace and defence group EADS today took the first step towards joint exploration of business opportunities in defence and aerospace. Mr. M. V. Kotwal Senior Executive Vice President of L&T and Mr. Daniel Baubil, Executive Vice President and Head of Global Industrial Development of EADS, signed a Memorandum of Understanding (MoU), to establish a long-term, profitable and stable relationship to better address the needs of the aerospace and defence markets in India and around the world. The signing took place at the Aero India 2007 exhibition in the city.

The agreement between L&T and EADS defines the formation of working teams to build a joint business model and appropriate common strategies on several key segments of the aerospace and defence market.
